SITUATION

COLOURANT FOR LAKES AND PONDS

10L per Ha of water with an average depth of 1 metre.
i.e. 1 Litre per 1 Mega litre

CRITICAL COMMENTS

Colourant to improve appearance of lakes and ponds.

TURF COLOURANT

600 - 800 ml per Hectare
6 - 8 ml per 100 sq. Mtr.
25 ml per 5 Litre

For boom application to parks, ovals and fairways.
For greens.
For back packs and hand applicators.

GENERAL INSTRUCTIONS

Application of Envirodye Aqua to contained bodies of water helps maintain their natural beauty and appearance. Disperse evenly throughout water body. Envirodye Aqua can also be applied to turf surfaces and for divot repair to improve appearance.

MIXING INSTRUCTIONS

To achieve thorough mixing and improved coverage premix EnviroDye with water in ratio 1:10 before application. Wash out all spraying equipment thoroughly after use as residue can cause discolouration of subsequent sprays.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND THE ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with used container. Non considered harmful to hardy fish at use concentrations. Test before use with any delicate or valuable aquatic organism.

STORAGE AND DISPOSAL

Store in closed, original container in a well ventilated area, as cool as possible. Triple or, preferably pressure rinse containers before disposal. Add rinsings to spray tank or knapsack mix. Do not dispose of undiluted chemicals on site. Break, crush, puncture and bury empty containers in a local authority landfill. If not available bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS Avoid contact with skin and eyes. Wear overalls, rubber gloves, goggles or disposable face shield. After each days use wash contaminated clothing, gloves and face shield with soap and water.

FIRST AID

If poisoning occurs contact a doctor or Poisons Information Centre (Ph 13 11 26). If in eyes hold open and flood with water for at least 15 minutes and see a doctor. Additional information is listed in the Materials Safety Data Sheet.
