#### GENERAL INSTRUCTIONS

Glysowet surfactant will assist wetting of plant surfaces, giving more uniform spray coverage and increased retention of the applied spray. Measure the required amount of Glysowet surfactant and add to the spray tank near the end of the filling process to minimise foaming.
