GENERAL INSTRUCTIONS

Tribute is a highly penetrating spray adjuvant suitable for use with many post emergent herbicides. Tribute combines an optimum spreadable oil with unique blend of nonionic surfactants to provide outstanding wetting and spreading. Tribute can generally be used at half the rate of most spray oils.

COMPATIBILITY

Tribute is compatible with a wide range of pesticides including Quizalofop-p-ethyl Fluazifop Clodinafop Propargyl / Cloquintocet-Mexyl Clethodim Propaquizafop. If in doubt it is a sensible precaution to trial by application to a small area before committing to a large scale application.

PRECAUTIONS

Read all directions for use on the Tribute label and on pesticide label. The pesticide manufacturers directions and recommendations always take precedence over directions contained on this label.

EXPLOSION WARNING: Apparently "EMPTY" containers may contain liquid and/or vapour residue which can be explosive if exposed to an ignition source at temperatures above 90°C. Such conditions may occur during cutting or welding. DO NOT cut or weld these containers. Explosion may cause injury or death.

MIXING

Quarter fill spray tank with water and add required amount of pesticide. Continue filling under agitation. When half full add required amount of Tribute and continue to fill tank under agitation. Do not store tank mix for longer than required for immediate use.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the chemical or used container.

STORAGE AND DISPOSAL

Store in closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple or, preferably, pressure rinse containers before disposal. Add rinsings to spray tank or knapsack mix. Do not dispose of undiluted chemical on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, puncture and bury empty containers in a local authority landfill. If not available bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS

Avoid inhalation or skin contact of spray mist. Consult the label of pesticide(s) used for directions on protective clothing required.

FIRST AID

If poisoning occurs contact a doctor or Poisons Information Centre (Ph 13 11 26). If swallowed, DO NOT induce vomiting. Give a glass of water.
